#### BACKGROUND

The Treasurer's Report contains information on the investment activities for the month of January 2015. The source of the reported current value of City investments is data obtained from Interactive Data Services. Attachment A contains information prepared by Chandler Asset Management, and includes a Portfolio Summary, Holdings Report, Book Value Report and Compliance with Investment Policy statement.

#### DISCUSSION

As of January 31, 2015, the total book value of the investment portfolio was \$57,143,825.09, as compared to \$56,597,696.88 at December 31, 2014. The weighted average investment yield for January 2015 was 1.27%, which was slightly lower than the yield of 1.30% for the prior month. Additionally, the City's Local Agency Investment Fund (LAIF), which is used for short term investment and functions like a savings account, had a balance of \$15,953,747.29 at January 31, 2015. This brings the total portfolio value as of January 31, 2015 to \$73,097,572.38, as compared to \$65,195,134.91 at December 31,

2014.

All City investments are GASB rated No. 1, where the custodian (The Bank of New York Mellon Trust Company, N.A.) acts as an agent of the City, and is not a counterparty to the investment transaction, and all securities are held in the name of the City of Brea. The custodial account at Bank of New York and account records with Chandler Asset Management has been reconciled for the month. The City of Brea has sufficient cash flow to meet its expected expenditures for the next six months.

#### FISCAL IMPACT

During the month of January, the total value of the City's investment portfolio increased by \$7,902,437.47. The increase was primarily due to the receipt of Sales Tax and property taxes during the month.

#### **RECOMMENDATION**

Accept project as complete and authorize City Clerk to record Notice of Completion.

#### BACKGROUND

On June 3, 2014, Council awarded a contract in the amount of \$797,745.50 to Marina Landscape, Inc. of Anaheim for construction of the Imperial Highway Greenbelt Improvements, Project 7285. The project installed environmentally conscious landscaping and irrigation system within the former County of Orange parcel located on the south side of Imperial Highway from Valencia Avenue to the Orange County Flood Control Channel. This project also installed drainage improvements, a 4-foot wide meandering trail, vine planting/screening system and a City entry monument sign. As directed at the Council Study Session in August 2013, the recommended lighting along the trail has been installed for security and an area located southerly across from the intersection of La Floresta Drive and Imperial Highway was preserved for future art work.

#### DISCUSSION

Marina Landscape, Inc. has completed the project and fulfilled its obligations to the City per the subject contract. The total amount of change orders approved for this project

was \$36,861.10 which equated to 4.6% of the original contract amount. The final contract amount is \$834,606.60. One of the significant change orders was the installation of landscaping and irrigation system on the privately owned parcel adjacent to the project (west of PK Burger Restaurant) as approved by Council in October 2013. Addition of this improvement enhances the consistency and aesthetic appeal to the overall landscaping project along Imperial Highway. Finally, a City entry monument sign was installed and the construction cost of approximately \$23,000 will be reimbursed by the La Floresta developer as part of the Development Agreement.

#### FISCAL IMPACT

The total approved construction budget for the project was \$917,408.00 with funding coming from the County Landfill Agreement Fund 560 (Capital Landfill Mitigation Improvements). The savings of \$105,801.40 will be returned to Fund 560 and will be available for reprogramming. There is no General Fund impact.

#### **SUMMARY**

The City Council awarded a contract to Marina Landscape, Inc. to install landscaping and irrigation improvements on the south side of Imperial Highway across the La Floresta Development in the amount of \$797,745.50. Total change orders amounted

#### RECOMMENDATION

Accept project as complete and authorize City Clerk to record Notice of Completion.

#### BACKGROUND

On November 18, 2014, Council awarded a contract in the amount of \$215,902.50 to R.J. Noble Company of Orange, California for the construction of Wildcat Way Rehabilitation, Project 7302. The project resurfaced the asphalt pavement on Wildcat Way from Lambert Road to the Brea-Olinda High School entry driveway. In addition, the project replaced damaged and/or uplifted curb and sidewalk, adjusted water valve boxes and sewer and storm drain manhole frames and covers to finish elevation, and restriped traffic markings within the project limits. The curb access ramps were also modified at the intersection curb returns and driveway entryways in accordance with the latest Americans with Disabilities Act (ADA) requirements.

#### DISCUSSION

R.J. Noble Company has completed the project and fulfilled its obligations to the City per the subject contract. The total net change orders approved for this project were \$3,578.62, which equated to 1.6% of the original contract amount. The final contract

amount was \$219,481.12. The contract change orders were as follows:

- 1. Over-excavated portions of existing asphalt to stabilize sub-base
- 2. Adjustment of final bid quantities

Below is a summary of construction contract costs:

#### FISCAL IMPACT

The total approved construction budget for this project was \$248,288 with funding coming from Fund 260 (Measure M). The construction contract savings of \$28,807 will be available for reprogramming. There is no General Fund impact.

#### **SUMMARY**

The City Council awarded a contract to R.J. Noble Company to resurface Wildcat Way from Lambert Road to the Brea-Olinda High School entry driveway in the amount of \$215,902.50. The total change orders amounted to \$3,578.62 for a final contract amount of \$219,481.12. The project is now complete and staff is recommending that Council accept the project as complete and authorize City Clerk to record Notice of Completion.

#### BACKGROUND

In January 2015, the Successor Agency to the Brea Redevelopment Agency account with Bank of New York Mellon (BNY) was officially closed due to investments being liquidated and transferred to the Successor Agency's Local Agency Investment Fund (LAIF) to meet anticipated expenditure needs. This report contains information on the investment activities for the month of January 2015.

#### DISCUSSION

As of January 31, 2015, the Successor Agency's Local Agency Investment Fund (LAIF), which is used for short term investment and functions like a savings account, had a balance of \$1,493,816.48 at January 31, 2015. The total portfolio value as of January 31, 2015 was \$1,493,816.48 as compared to \$1,492,859.92 at December 31, 2014. The Successor Agency to the Brea Redevelopment Agency has sufficient cash flow to meet its expected expenditures for the next six months.
