TRAFFIC COMMITTEE MINUTES – Thursday, June 20, 2019

TIME: 5:30 pm

LOCATION: Executive Conference Room, Level 3

- I. Call to Order/Introductions - *The meeting was called to order at 5:30 pm.*
- II. Approve minutes of May 16, 2019 Regular Meeting – *Committee approved minutes.*
- III. Matters from the Audience – *Robert Warkenton of 1408 Whittier Ave, handed out the attached letter to Orange County Public Works regarding the Brea Canyon Rd Widening Project that states his concerns and his opposition to the project. He also raised concerns with the speed humps on Whittier are not as effective due to two coats of slurry since they were installed. He added that there was trash in gutter lines on Puente St and on Berry Street and requested additional street sweeping in that area. Lastly, he felt that the flashing red ped-xing for the tracks on Brea Blvd and on State College Blvd. was confusing and feels that is was malfunctioning. Committee received the comments and staff said they would follow-up on the speed humps and maintenance issues. Staff also clarified that is the signal at Brea / Tracks was working as intended.*
- IV. Santa Fe Traffic Calming Monitoring Data – *City Engineer Ho opened and presented the item to provide background and history of the traffic calming improvements along Santa Fe. He summarized and compared the before and after the traffic calming improvements traffic volumes, collision history and traffic speeds to show the calming measures are working. Traffic Engineer Roseman to bring this item back at next meeting with recommendations. The Traffic Committee concurred.*
- V. Traffic Collisions and Citations Report Options – *City Engineer Ho presented the item that was based on the request of the Traffic Committee to have staff present collision and citation data at every meeting. Ho referred to the staff report attachment that was a sample used by the City of Yorba Linda. Police Chief Burks provided a handout that was used in the past by the Traffic Division for Traffic Committee’s review. Traffic Committee requesting monthly data on Traffic Citations, DUI’s, Collisions, Distracted Driving, Month to Month comparisons with the previous 3 months data and locations of the occurrences for Committee review. Police Chief Burks will provide the requested information.*

VII. Project Updates – Signal Synchronization update to be provided at next meeting.

VIII. Traffic Committee Discussion

TCCR Hunter – requested Police Chief Burks to work with other Orange County Law Enforcement to stop Car Clubs and Fireworks from entering the City of Brea. Chief Burks informed the Committee that he is working with the other agencies law enforcement groups. Also requested a pre-meeting with staff, Traffic Engineer and school district before the Cliffwood working group kick-off meeting.

TCCR Martorella – Noticed that no vehicles stop for the school bus when the STOP signs are activated on Santa Fe. He also requested more additional patrols in the Blackstone area at night. He noticed during rush hour on northbound Brea Blvd approaching Imperial that there is backup. Staff informed him that Caltrans is doing work and has affected the traffic signal timing and will soon return the timing back to normal within 1 month.

TCCR Chandler – requested the No Left Turn sign on Kraemer Blvd south of Birch in the southbound direction be removed, leftover signage from previous project.

TCCR Dooley – requests a list of projected construction projects with scheduled lane closures and provide to the Traffic Committee.
