Intersection Related Collisions:

- 1. All collisions are considered intersection related if they occurred 50' or less from the intersection.
- 2. Collisions are considered intersection related up to 150' if they adhere to the following: a) Two or more vehicles are involved, b) The first two vehicles are proceeding straight (this includes slowing/stopping or stopped), c)
 The first two vehicles are headed toward the intersection, & d) The collision type is rear-end.
