Becoming Austin Nation

In March, the Curtis Theatre presented the third installment of the Amplify initiative *Becoming Austin Nation - From Crack to PhD: A Drag Queen's Story*. This one-person show is an autobiographical telling of Austin Nation's story – from his early days of experiencing racism, sexism, and homophobia through his battles with HIV, AIDS, and addiction, to his 20+ year sobriety, academic success, and love of drag. This powerful narrative is partially a cautionary tale, but ultimately has a heartfelt message of hope and courage. In the Q&A session that followed the performance, audience members shared how deeply moved they were and expressed heartfelt gratitude to Austin for sharing his story as well as the Curtis Theatre for providing a platform.



II. GALLERY

Attendance

March Highlights

- In preparation for *Made in California*, Gallery Staff sent out all of the MICA acceptance notifications on March 9th and have been maintaining constant communication with the 101 accepted artists since then. As well, Staff have begun to prepare for all of the elements that go into the show, such as installation, marketing, new virtual events, etc. This year's MICA is sure to be a great one due to the excited, new group of artists participating this year.
- *Domestic Detritus* closed on March 24th and installation has started. Staff has been busy arranging artwork pickup, shipping and intaking new pieces for the next show.



Special Events

Spring Craft Boutique

The Spring Craft Boutique was a two-day event this year, held on March 17th and 18th at the Brea Community Center. There were over 2,500 customers and community members who shopped at the 23rd annual City of Brea Spring Craft Boutique. The boutique featured 223 vendors, selling unique one-of-a-kind seasonal and year-round gifts and décor, wearable art, jewelry, florals, baby items, tasty goodies and much more. We had more attendance and more vendors, than the previous year, helping us get back to our pre-pandemic numbers and community outreach. Win-win in or books. This is a really fun event where the community is able to shop local, sample and purchase unique items from small business owners.



Pet Expo

We are so excited to be hosting our fourth Annual Pet Expo on April 1st from 9 a.m.-3 p.m. at the Brea Community Center. The Pet Expo will be featured over 100 vendors, highlighting pet products, learning opportunities and pet adoptions as well as demonstrations from Anaheim Police Department K-9 Unit as well as the Brea Police Department. The community will be able to see a variety of K-9 techniques, including a drug sniffing drill, dog obedience and simulation bite. This event will cost \$2.00 for admission and we hope you all are able to attend this fun local event for the community.
