Minutes of the Special Meeting of June 8, 2022

CALL TO ORDER

The Special Meeting of the Parks, Recreation & Human Services and Cultural Arts Commissions was called to order by Cultural Arts Chair Perez at 5:01 p.m.

Parks, Recreation and Human Services Commission Vice Chair, Craig Livingston and Commissioners Joseph Covey and Tom Donini were present at the Brea Senior Center. Chair Gill Realon and Commissioner Bill Higgins were absent.

Cultural Arts Commission Chair Blake Perez; Vice Chair Sara Trujillo; and Commissioners Robyn Price; Ben Schultz; and Robert Warkenton were present at the Brea Senior Center.

ACTION

City of Brea/Community Services FY2022/23 Budget and Program Fees

Management Analyst Colacion provided Commissioners a PowerPoint presentation and discussed the budget workshop overview, City Council top priorities, the City of Brea fiscal policies statement, the 2022-23 budget process, budget highlights, economic outlook, fund revenues, sales tax, property tax and transient occupancy tax projections, Community Service revenue projections, 2022-23 General Fund expenditures, assumptions and decision package requests.

In response to Cultural Arts Commission Vice Chair Trujillo, Management Analyst discussed the City of Brea fiscal year.

Parks, Recreation and Human Services Commissioner Donini discussed the American Rescue Plan Act (ARPA) funding and wanted a comparison to prior year numbers.

Management Analyst Colacion discussed the ARPA funds and how those resources will be used prior to year 2024.

In response to Parks, Recreation and Human Services Commissioner Donini's question, Management Analyst Colacion provided more details on the decision package for the Homeless Liaison Officer.

In response to Cultural Arts Commissioner Warkenton's inquiry, Management Analyst Colacion discussed how costs for repairs for Curtis Theatre are incorporated into the budget. She also noted that a similar repair path was completed in recent years for the Brea Art Gallery.

In response to Cultural Arts Commissioner Warkenton's inquiry, Management Analyst Colacion noted that art work maintenance is funded by developers.

In response to Parks, Recreation and Human Services Vice Chair Livingston's question, Deputy Director Matlock provided Commissioners with further information regarding the western expansion of the Tracks at Brea through La Habra. He discussed the easement, right of way, grant opportunities, and how the cities of La Habra and Brea would be working together.

Deputy Director Matlock and Community Services Manager Hernandez provided Commissioners a PowerPoint presentation on Fiscal Year 2022-23 Community Services fees and discussed how fees are created and notable fees for the year.

In response to Parks, Recreation and Human Services Commissioner Donini's inquiry, Community Services Supervisor Mendoza discussed the resident and non-resident fees and how both participate in Community Center programs.

In response to Parks, Recreation and Human Services Commissioner Donini's question, Deputy Director Matlock discussed cost recovery and program subsidization across Community Services.

In response to Cultural Arts Commissioner Warkenton's inquiry, Deputy Director Matlock discussed the fee increases, how those numbers were decided upon, and the how changes to fees could be increased during future budgets.

Motion was made by Cultural Arts Commissioner Warkenton, seconded by Commissioner Price to receive and file the Fiscal year 2022-23 Community Services program fees.

Arovista Park Modernization Design and Golf Safety Netting Funding

Deputy Director Matlock introduced item and provided background on the Arovista Park Modernization project and discussed golf safety netting.

In response to Parks, Recreation and Human Services Commissioner Donini's question, Public Works Superintendent Bowlus noted that construction documents and specifications would be included in the design plans and will show cost estimates for the entire project.

Deputy Director Matlock noted that this action item would be approving the \$953,000 for the golf course safety netting and park design. He also discussed that the firm David Volz Design was the best choice for the project based on all of the evaluation criteria.

In response to Parks, Recreation and Human Services Vice Chair Livingston's inquiry, Deputy Director Matlock discussed the estimated price that was noted in packet and how that number has changed with the awarded firm.

Motion was made by Parks, Recreation and Human Services Commissioner Donini, seconded by Commissioner Covey to approve up to \$953,000 from the Park Development Fund 250 for the design and safety netting for Arovista Park modernization.

SUBJECT: Approval of Concept Plans for Arovista Park Modernization

RECOMMENDATION

That the Parks, Recreation and Human Services Commission approve the redesigned concept plans for the Arovista Park Modernization Project, as presented, and direct staff to move the item on to City Council for consideration and approval.

BACKGROUND/DISCUSSION

At the December 7, 2022, Parks, Recreation and Human Services Commission meeting staff presented detailed concept plans for the Arovista Park Modernization project as a discussion item. Staff is now seeking a formal Commission approval of the plans, as presented, and for the Commission to direct staff to move the concept plans on to City Council for consideration and approval.

SUMMARY/FISCAL IMPACT

The City Council has approved \$9.7 million to be budgeted for this project through the Capital Improvement Program (CIP) Budget. Staff has also secured grant funds totaling \$205,000 through Proposition 68 funds and a \$625,000 contribution through County of Orange Supervisor Doug Chaffee's office.
