TRAFFIC COMMITTEE MINUTES - January, 19, 2023

• Call to Order/Introductions - The meeting was called to order at 5:30 P.M.

- Approve minutes of the November 17, 2022, Regular Meeting Motion was made by Committee Member Hickenbottom, seconded by Committee Member Zambon, to approve the minutes as presented. The Committee voted unanimously to approve the motion.
- Matters from the Audience There were no members of the audience present.
- Traffic Collision and Citations Report The report was received and filed.
- Puente St. and Whittier Ave. Intersection This item was placed on the agenda at the request of Committee Member Zambon. The City Traffic Engineer provided background on the history of the intersection noting that there have been multiple crashes at the intersection involving northbound to westbound vehicles striking the raised median and rock on the west leg of the intersection. The City implemented a revised striping scheme more than a year ago to address that pattern of crashes. In addition, staff is working on design plans for speed humps on Puente north of Whittier, which will be brought to the Committee for their consideration at a later meeting. Committee Member Zambon requested that cat-track striping be installed at the intersection to better guide motorist around the median. The Committee also requested that yearly accident reports for the intersection be provided at the next meeting for review and discussion by the Committee.
- **Project Updates** City Traffic Engineer and staff reported on the following items:
 - Falcon Elementary The City Traffic Engineer shared what was discussed during the meeting held with BOUSD staff, residents, and parents at Falcon Elementary on January 10th. BOUSD confirmed that the morning arrival period has fewer traffic issues than the dismissal period. The City Traffic Engineer will present traffic data and the results of the crossing guard study at the February

- Traffic Committee meeting.
- Brea Junior High School City staff confirmed that the signage and signal improvements at the Lambert and Brea intersection will begin construction by the end of January. The City Traffic Engineer will coordinate with BOUSD on the notifications and schedule.
- Lambert / 57 City staff confirmed that Caltrans will be demolishing and reconstructing the flawed new connector bridge in the near future. Further scheduling and project updates to follow.
- Integrated Crime Center City staff provided a summary of the January 17th City Council meeting item. The Committee expressed concerns that requests for video footage and other information from the public could have high, unintended cost impacts.
- Brea Canyon Roadway Widening DEIR City staff provided a summary of the January 17th City Council meeting item which outlined issues and concerns with the environmental document for the project. City staff will submit a formal comment letter to Orange County summarizing the City's concerns by February 3rd.
- Brea Canyon Road City staff confirmed that the roadway slurry project is scheduled for Wednesday-Friday, 8:00am-4:00pm.

Committee Member Comments –

- <u>Vice Chair Hickenbottom</u> Requested to have the City staff contact Caltrans to recheck the clocks on Imperial Hwy.
- <u>Committee Member Zambon</u> Expressed appreciation for completing the cold patching of potholes on State College Blvd.
- <u>Committee Member Zambon</u> Requested the City staff to review Elm St. and Laurel Ave. stop signs, and potentially implement light-up stops signs.
- Adjourn The meeting was adjourned @ 6:20 pm. Next scheduled meeting is February 16, 2023.
